### Proposition 65 the Safe Drinking Water and Toxic Enforcement Act of 1986

Proposition 65 requires business to provide warnings to California about significant exposures to chemicals that cause cancer, birth defects or other reproductive harm. These chemicals can be in the products that Californians purchase, in their homes or workplaces, or that are released into the environment. By requiring that this information be provided, Proposition 65 enables Californians to make informed decisions about their exposures to these chemicals.


### Proposition 65 list of chemicals known to cause cancer, birth defects or other reproductive harm 65

Proposition 65 requires California to publish a list of chemicals known to cause cancer, birth defects or other reproductive harm. This list, which must be updated at least once a year, has grown to include approximately 900 chemicals since it was first published in 1987.
